## ABOUT

---

The Ministry for Ethnic Communities is the government's chief advisor on ethnic communities, ethnic diversity and the inclusion of ethnic communities in wider society.

We work with communities, other government agencies and a range of organisations to help increase social cohesion and ensure Aotearoa New Zealand is a place where everyone feels welcome, valued and empowered to be themselves. We also provide services and support directly to ethnic communities.

## WHAT WE FUND

---

The [Ethnic Communities Development Fund](#) has \$4.2 million a year available for projects that support ethnic communities to grow their skills, celebrate their culture and take part in society. The fund is also available for initiatives that support ethnic communities as they deal with the challenges of COVID-19.

The priorities of the Fund are:

- grow a socially inclusive Aotearoa New Zealand,
- educate New Zealanders about the contribution/benefits of ethnic communities,
- develop capability and ability within ethnic communities,
- encourage participation in employment and society, including via community employment initiatives, support ethnic community-led development projects,
- support ethnic communities to thrive through the practice and celebration of culture,
- support alternative means for ethnic communities to stay socially connected, and
- improve community resilience and support their recovery from COVID-19.

## WHAT WE DON'T FUND

---

There are some projects that are not able to get funding through the Ethnic Communities Development Fund, like:

- grants to individuals
- grants for capital works
- already completed projects
- debt repayment
- activities intended to generate profit
- businesses for profit, political goals, or religious ministry
- projects to raise money
- alcohol or similar substances.
- operational or business as usual costs

*Please note: In response to the impact of COVID-19 a limit of \$5,000 on the grant amount is placed for in-person events*

---

Tasman District Council provides funding and advice to community organisations to support them with their community initiatives. Grants are predominantly for 'not for profit' community and voluntary groups. We support a range of initiatives such as arts, waste minimisation, youth, environment, events and recreational activities; all working towards benefiting Tasman District communities.

## FUNDS ON OFFER

### COMMUNITY GRANTS

To support projects, delivery of services, infrastructure and community-based solutions

---

We are the Whānau Ora commissioning agency for Te Waipounamu.

We work on behalf of the nine iwi of Te Waipounamu to determine the best ways to support whānau development.

Our approach aims to create social impact by investing directly in initiatives developed by whānau or community groups. We also support a significant workforce of Whānau Ora Navigators who work directly with whānau to support them to develop their own pathway plans.

All our mahi is centred on the philosophy that whānau must be placed at the centre of service design and deliver, supporting them to realise their own solutions.

## WHO WE FUND – WAVE FUNDING

---

Wave funding is for whānau, established organisations, community groups and small to medium businesses.

We have refreshed the scope of what we fund through our Wave funding. For whānau, community groups, and establishing organisations this means:

- Projects that seek to help whānau and communities thrive post COVID-19
- Projects that seek to support our Whānau Ora outcomes

**NELSON CITY**  
**CREATIVE COMMUNITIES**  
**LOCAL ARTS FUNDING SCHEME**



**ABOUT:**

Arts Council Nelson administers the Nelson City Creative Communities Scheme [CCS] on behalf of Creative New Zealand and Nelson City Council. Grants contribute toward arts-based projects that clearly demonstrate community benefits within the Nelson City Council wards only. The scheme has \$46,000 to allocate annually over two funding rounds which close in April and September each year.

Creative Communities Scheme funding is available in each region nationally, applicants should apply to the region where the benefits of their project will be realised.

**Funding Criteria:** Projects must meet one or more of these three funding criteria-

- **Broad Community Involvement** - the project will create opportunities for local communities to engage with and participate in arts activities.
- **Diversity** - The project will support the diverse arts and cultural traditions of local communities, enriching and promoting their uniqueness and cultural diversity.
- **Young People** - The project will enable and encourage young people (under 18) to engage with and actively participate in the arts.

**WHO WE FUND**

Individuals who are New Zealand citizens or permanent residents or groups can apply for CCS funding.

**WHAT WE CAN FUND**

- > materials for arts activities or programmes - > venue or equipment hire
- > personnel & administrative costs for short-term projects - > promotion & publicity of arts activities.

**WHAT WE DON'T FUND**

- > ongoing administration or personnel costs that are not related to the specific project
- > costs for projects already started or completed
- > travel costs to attend performances or exhibitions in other areas
- > buying equipment, such as computers, cameras, musical instruments, costumes, lights or uniforms
- > entry fees for competitions, contests and exams
- > prize money, awards and judges' fees for competitions > royalties
- > the purchase of artworks for collections > the costs of running fundraising activity
- > debt or interest on debt

## APPLICATION TIPS

A full guide for applicants is available on the ACN website: <http://www.acn.org.nz/funding.html> along with an overview brochure in 11 languages.

Whilst there is no set limit that may be applied for, grants for project assistance are generally around \$1,200 - \$1,500 although worthy projects requiring greater assistance will be certainly be considered by the Assessment Committee. Funding decisions are usually confirmed within six weeks from closing date

## ABOUT

---

Network Tasman Charitable Trust has been established to:

- ❖ Allocate up to \$200,000 annually to individuals, groups and organisations within its distribution area by way of grants and scholarships.
- ❖ The grants allocation is to acknowledge contributions to the growth of the Company (Network Tasman Ltd) from those past and present users of our lines business but who do not receive, or have not received annual discounts and dividends on the days they are made.
- ❖ Fund the Sir Wallace Rowling Scholarships for up to three secondary students each year.

## WHAT WE DON'T FUND

---

- ❖ No applicant can expect an ongoing grant. As a general rule the Trust will not provide funding for more than three consecutive years to any one organisation.
- ❖ Grants will not be made for projects which have budgeted a deficit. Expected income or funding sources that are claimed for in the application must be reasonable and likely to be achieved.
- ❖ Grants may not be used to fund debt repayment.
- ❖ Grants will not be provided to private businesses, government agencies or political parties.
- ❖ No retrospective funding.
- ❖ Purchase or improvement of privately-owned facilities.
- ❖ Activities that involve any tobacco, illegal substances and gaming.
- ❖ Activities or initiatives where the primary purpose is to promote religious belief or political activities.

## WHAT WE CAN FUND

---

- ❖ Funding generally falls into five main categories:
  - Social support services
  - Sport and recreation
  - Education
  - Art and Culture
  - Environmental and Energy-saving
- ❖ Generally, grants will not be available for wages or operating costs however consideration will be given to funding the cost of providing specialist services, training and professional development.

## GENERAL GUIDELINES

---

- ❖ Applicants must be end users of Network Tasman Limited line facilities as recorded in the records of the Company. In the event of the applicant being an organisation, the purpose of the grant must be of significant benefit to the district serviced by the Company.
- ❖ Projects must be capable of being completed or performed within one year of date of receipt of funding.
- ❖ Evidence must be provided of other funding secured or anticipated including cash, loans, anticipated income and in-kind contributions.
- ❖ The maximum grant is generally \$3000.
- ❖ Details of grants will be publicly advertised in the Trust's Annual Report.
- ❖ Grants are unlikely to be allocated to organisations which have already incurred financial deficits or are budgeting a deficit budget for projects.
- ❖ Successful applicants that have failed to complete their accountability form within 12 months will be ineligible for further funding until outstanding forms are completed.
